Dear Chairman Boozman and Ranking Member Schatz:

We write to request appropriate funding towards the Department of Veterans Affairs (VA) State Veterans Home Construction Grant Program. We appreciate efforts made in recent years by the Subcommittee on Military Construction, Veterans Affairs, and Related Agencies to reduce nationwide backlogs. We ask that you build on this progress by providing robust funding in Fiscal Year 2021 to reflect the importance of quality State Homes for our veterans and continue the program's more than 50 years of success.

Today there are 158 State Veterans Homes in all 50 states and Puerto Rico. Veterans Homes provide veterans disabled by age, illness, or other conditions with a wide range of essential services, including skilled nursing, domiciliary care, rehabilitation therapy, mental health treatment, recreation activities and more. These facilities are beloved by their communities and can help prevent veterans from relocating far from their families.

Federal funds made available through the VA State Home Construction Grant Program allow states to modernize existing facilities and begin construction at new sites that will serve veterans in need. It is crucial that states can rely on VA to uphold its end of the bargain when starting new projects. Fully funding this account helps ensure Veterans Home construction occurs on schedule.

Ultimately it is our veterans who pay the price when this program is under resourced. Given that many states have Veterans Homes in need of renovation as well as planned construction projects in the pipeline, it is critical that this program has the tools it needs to be a continued success. As the Subcommittee considers appropriations for 2021, we ask that you fully fund the VA State Home Construction Grant Program.
