Dear Secretary Lutnick,

At a time when our nation is experiencing an unprecedented affordability crisis, President Trump's decision to impose sweeping tariffs on goods from virtually every country in the world will send a chill through small businesses across the country. Most small businesses operate on razor thin margins, so any increase in costs could be devastating for both day-to-day operations and business' long-term success. Now is the time to invest in our small businesses to ensure they have the resources necessary to navigate today's high cost environment. Across-the-board tariffs will have the opposite effect, squeezing small firms that lack the capital and resources to mitigate the worst effects of President Trump's new trade barriers. Given this, we urge you to work with the President to immediately reverse course on these broad-based tariffs to end the needless suffering this administration has imposed on small businesses across the country.

Small businesses are the lifeblood of our communities - they create employment opportunities, provide unique goods and services, and bolster local economies. With small businesses already being crushed under the weight of high costs and interest rates, we must do all we can to cut red tape and help them thrive – not create additional affordability challenges and uncertainty. The President's reckless across-the-board tariffs are putting small businesses in an impossible position. Business owners are forced to decide between absorbing the costs while risking staff layoffs and potential closure, or passing the increased costs along to their customers with whom they have built a relationship and who are already facing high prices due to inflation. Simply put, President Trump's blanket tariffs will have catastrophic impacts on American small businesses and consumers alike.

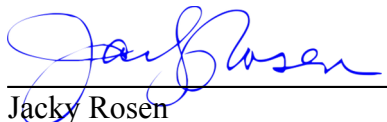
